**DISCLOSEABLE TRANSACTION –  
PROVISION OF FINANCIAL ASSISTANCE  
IN RELATION TO RENEWAL OF LOAN**

The Board wishes to announce that on 3 October 2019, the Lender (a wholly-owned subsidiary of the Company) and the Borrower entered into the Third Loan Renewal Agreement, pursuant to which the Lender agreed to renew the Loan in the aggregate principal amount of HK\$12.2 million to be repayable on 4 October 2020.

As the percentage ratios under Rule 14.07 of the Listing Rules in respect of the monetary advantage together with the value of the financial assistance pursuant to the renewal of the Loan under the Third Loan Renewal Agreement (under the assets and consideration ratios) and the interest income for the Loan during the period so renewed (under the revenue and profits ratios), when aggregated with the monetary advantage or interest income derived under the Loan prior to such renewal, are more than 5% but less than 25%, the renewal of the Loan under the Third Loan Renewal Agreement constitutes a discloseable transaction for the Company under Chapter 14 of the Listing Rules and is therefore subject to the reporting and announcement requirements under the Listing Rules.

The Board wishes to announce that on 3 October 2019, the Lender (a wholly-owned subsidiary of the Company) and the Borrower entered into the Third Loan Renewal Agreement, pursuant to which the Lender agreed to renew the Loan in the aggregate principal amount of HK\$12.2 million to be repayable on 4 October 2020.

## **INFORMATION ON THE BORROWER**

The Borrower is a company incorporated in Hong Kong with limited liability which is engaged in trading of clothing. To the best of the knowledge, information and belief of the Directors having made all reasonable enquiry, each of the Borrower and its ultimate beneficial owner(s) is a third party independent of the Company and its connected persons (as defined under the Listing Rules).

## **REASONS FOR AND BENEFITS OF THE ENTERING INTO THE THIRD LOAN RENEWAL AGREEMENT**

The principal activity of the Company is investment holding. Its subsidiaries are principally engaged in money lending and trading of goods and commodities. The Lender is a company incorporated in Hong Kong with limited liability, a wholly-owned subsidiary of the Company and a licensed money lender in Hong Kong registered under Money Lenders Ordinance, Chapter 163 of the Laws of Hong Kong. The granting of the Loan to the Borrower pursuant to the Loan Agreements and the renewal of the Loans under the Third Loan Renewal Agreement are in the ordinary course of business of the Group. The Lender has financed the Loan with the Group's internal cash resources.

The terms of the Loan Agreements (including the interest rate and the term of loan) and the Third Loan Renewal Agreement were negotiated on an arm's length basis between the Lender and the Borrower and were on normal commercial terms based on the Company's credit policy. Taking into account the results of the Company's due diligence on the financial background and repayment ability of the Borrower and the stable interest income expected to be generated from the Loans and its renewals, the Directors consider that the terms of the Loan Agreements (including the interest rate and term of loan) and the Third Loan Renewal Agreement are fair and reasonable and the entering into of the Loan Agreements and the Third Loan Renewal Agreement is in the interests of the Company and its shareholders as a whole.
